## Investment Sub-Committee Review – Lori Klafehn

- 2) \$290K was withdrawn from the Communis account in September in order to pay for the heating/cooling upgrade at CTK.
- 3) John Schoen requested copies of the investment reports for Council members in the future.
- 4) The Education Fund accounts earned \$29K for the January to September period.
- 5) Copies of the updated "Saint Kateri Tekakwitha Parish Education Fund Charter" were distributed. John Aloisio requested that members review the document and email comments to him.

## Churches Financial Review (see handouts) - Carol Wilke

- 6) Balance Sheet (September):
  - a) The large balance in General Checking includes the transfer from the Communis account.
  - b) Accounts 1005 / 1006 / 1011 are liquid and available to use to cover expenses.
- 7) Revenue & Expenditures (September):
  - a) Collections are \$16 below budget YTD.
  - b) Salaries and Benefits are very close to budget.
  - c) Net Operating Revenue is \$36k negative YTD.

- 8) Revenue & Expenditures (month):
  - a) Current enrollment is 6 students greater than budgeted.
  - b) Net Operating Revenue is positive YTD.
