Year in Review –

July 2017 to December 2017

- School Enrollment Pre-K thru 5th 201 a slight increase form 194 from prior year
- Funeral Masses Celebrated 103
- Baptisms Celebrated 49
- Marriage Ceremonies 7
- Newly Registered Families since July 32, partially offset by a reduction of 6 families.
- Mass attendance 1606 (October 2017) vs. 1773 (October 2016), a decline of 167 or 9%.

Diocese of Rochester Program

The Family Ambassador Program awards a current Diocese of Rochester Catholic School family a \$500 tuition credit when they successfully refer a brand new family to one of the 18 Diocese of Rochester Catholic Schools in the Finger Lakes, Greater Rochester, and Southern Tier regions. The Family Ambassador Program builds the bridge between our Catholic schools and the community.



- The new family also receives a \$500 tuition credit when they enroll in a Diocese of Rochester Catholic school.
- The school that benefits from the new enrollment pays the two \$500 awards.


- For the six months ending December 31, 2017, offertory decreased 3% compared to the same period last year, and is 13% below budget. Average Mass attendance (based on the month of October 2017) was 1,606 versus 1,773 in October 2016. The reduction of 167 represents 9%.
- Revenue from tuition at Saint Kateri School increased 9% versus prior year as a result of higher enrollment (201 students in Pre-Kindergarten through Grade 5) and a modest increase in tuition per student. Grants, contingent upon availability, were below budget.
- Personnel costs were 3% higher in 2017 versus 2016 as we welcomed Father Evan Simington to Saint Kateri Parish and cost of living salary increases, offset slightly by staff attrition.



- Non-operating Revenue Year to Date includes net proceeds from the sale of the former Saint Salome Church plus interest and increases in market value of investments.
- Capital improvements were funded by a generous donation of \$11K
 designated for boiler controls and handicap accessible doors at Christ the King Church.
- Saint Kateri School purchased smart boards with funds raised from the Walk-a-Thon.
- The parish remains free of debt, managing cash flow prudently to cover the cost of daily operations with revenue from collections, tuition, donations, and grants.




